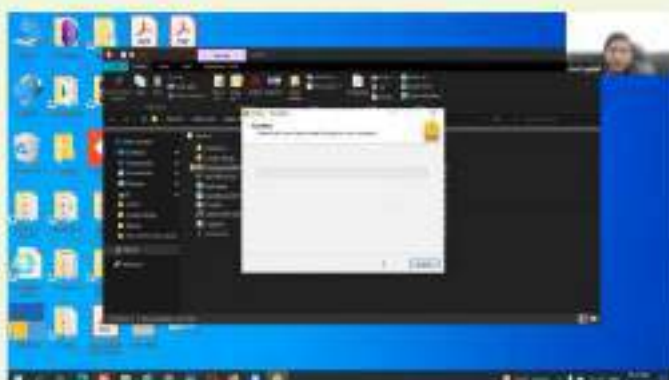

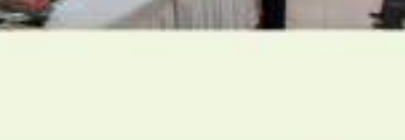

**Self Assessment (Section 59)**

- Section 59- Every registered person shall self-assess the taxes payable under this Act and furnish a return for each tax period as specified under section 39.
- Section 59(1) "self-assessment" means a return furnished under sub-section (2) of section 59 in which self-assessed tax has been paid in full.
- Section 59(2) Every taxable person shall discharge his tax and other dues under this Act or the rules made thereunder in the following order, namely:-
  - (a) self-assessed tax, and other dues related to returns of **previous tax periods**;
  - (b) self-assessed tax, and other dues related to the return of the **current tax period**;
  - (c) any other amount payable under this Act or the rules made thereunder including the demand determined under section 73 or section 74.

The sliced onions are then dried or dehydrated.
