#### Esteemed Members,

At the outset I am gratified and happy for the overwhelming response to the 1<sup>st</sup> RRC for the year 2014-15 held at Devi Garh, Udaipur. This RRC was a grand success and very well acclaimed by the members. Considering the demand from members for another RRC, AGFTC has decided to organize one more RRC.

The second Residential Refresher Course in my charge as President will be organized from 3<sup>rd</sup> April to 5<sup>th</sup> April 2015 at Fateh Bagh, Ranakpur. Luxurious comfort with academic enlightenment is motto for organizing RRC at this serene location.

At AGFTC, for the year 2014-2015, it is our mission to penetrate at the grass root level and be at the door step of honorable members through respective Associations and interact with them and also impart education through respectable faculties of Federation. Organizing RRC is a step in that direction. Union Budget, 2015 has been announced on 28th Feb and as such shall be one of the subjects. That apart we shall have other technical sessions also.

The Federation updates the members on all aspects of Taxation be it direct or Indirect Taxation. Two days RRC's and number of one day and half day seminars are organized every year. The regions are active in organizing one day seminars, study circles, workshops, RRC etc. in association with local Associations. The aim is to cultivate the strong bond of fraternity amongst members and professionals. The Federation tries to reach even to the remote places by organizing seminars.

Fateh Bagh, Ranakpur is a venue for time-travel to the 18th century, rediscover the Romantic Age. Located at 90 km from Udaipur and two centuries back in time stands the proud Fateh Bagh. The arresting architecture, period furniture and ethnic décor recall a gentler, more romantic time. Each room seems to have staged a story now lost in the wraps of time.

The imposing square shaped, beige walls and majestic arches, intricately carved pillars and pavilions, beautiful domes and the wonderful fountain in the foreground are all far removed from the 'functional minimalism' that is worshipped as design today. The palace and its hospitality are recreated history.

There is much to occupy you with in the present: a swim at the pool, a walk into the orchards, a visit to the famous Jain and Surya temples, exploring Ranakpur, a town outwardly stranded in medieval times.

Fateh Bagh is probably India's first attempt at 'relocating a fallen palace', faithfully preserving the rich Rajput architecture. Rawla Koshilav that flourished as a palace on the foothills of Aravallis near Jodhpur in 1802 became a neglected piece of heritage in the 20th century. In 2002, around 65,000 pieces of the crumbling palace were transported to a scenic spot in Ranakpur, amidst the orchards and on the banks of a rain fed river, to create Fateh Bagh!

#### **REGISTRATION:-**
