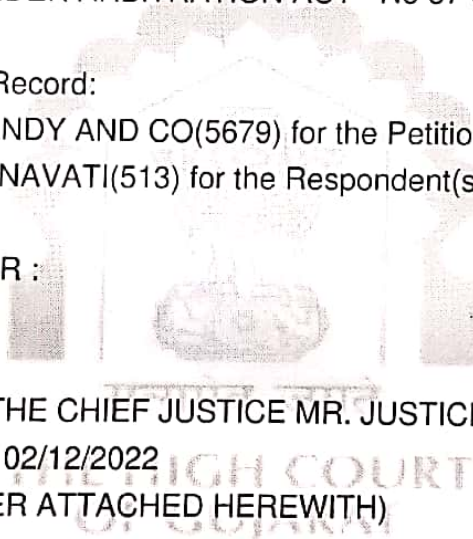

1. The dispute was referred to the Mediation as this Court found that there was likelihood of settlement being arrived at between the parties. Accordingly, mediation has been held and a consensus had been arrived at between the parties that appointment of Arbitrator would not survive since all issues are amicably resolved with the sincere efforts of both parties as indicated in the report of the Mediators dated 26.11.2022. In fact, the representatives of parties have also affixed their signatures to the file as a token of amicable resolution of disputes between them. The chart prepared by the federation which was taken on record by the Mediators has been made part of the

mediation proceedings with the consent of the parties.

2. In that view of the matter, this Court is of the considered view that appointment of Arbitrator does not arise and the petition stands disposed of by placing the report of the Mediators on record.

3. This Court places on record its appreciation to the learned Mediators who have played a vital role in ensuring the dispute between parties being resolved. The Mediation Center is directed to issue cheque towards Mediation Fee in favour of the Mediators as per the extant Rules within 15 days from the date of receipt of copy of this order.

4. Registry is directed to forward a copy of this order to the Gujarat High Court Mediation Center for taking steps to pay the amount to the learned Mediators. It is needless to state that in the event of any doubt or dispute were to arise both parties are at liberty to seek for revival of this petition.

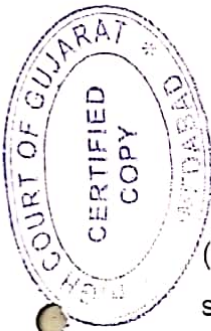

REPORT OF MEDIATION


Representatives of both the parties are present. The Federation (respondent/opponent) has after due deliberation considered the suggestions of the Central Gujarat Chamber of Tax Consultants (the applicants of the Arbitration Petition No.87 of 2019). A chart in a tabular form is provided by the Federation (respondent/Opponent) to the mediators showing the existing/amended provisions of the constitution, unamended provisions constitution of the Federation, suggestions of the applicant and the decision on each suggestion by the Federation. Point by point discussion was made with both the parties and the applicants were explained their suggestions and the decision thereon forming part of the Chart. The applicants are satisfied with the details given in the chart accepting the suggestions of the applicants partly or fully. A few more suggestions were also made by the applicants which the Federation assured that they will be deliberated and considered fairly. In view of the consensus arrived at between the parties, the

application for appointment for an arbitrator will not survive. All the issues are amicably resolved with the sincere efforts ^{of} both the parties  in the manner stated hereinabove. The representatives of the parties have put their signatures on the file as a token of amicable resolution of the disputes between them. The chart prepared by the Federation is taken on record and made part of the mediation proceeding with the consent of the parties. The Mediation is **successful**. The papers of the present mediation case may be placed before the appropriate court for passing appropriate order on judicial side.

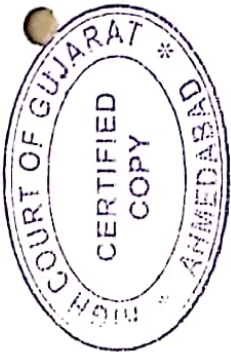


