- (i) Institutional members are requested to fill and submit the e-forms as per the prescribed process as per the amended rules and regulations along with payment of Rs. **500/-**.
 - (ii) The last date for filing nomination forms in the category of institutional member for the position of the member of the managing committee or senior vice president is **25th April 2025 up to 6.00 PM**.
 - (iii) The nomination form of the member should be filled in by the institution that has completed three or more years of its membership as of the date of filing of the nomination form.
 - (iv) Such nomination form shall be filled by that institutional member, who has been past president of that institution or any appointed office bearer and duly nominated by that respective institution by way of resolution and that resolution should be sent along with the nomination form.
 - (v) Such nomination shall be duly proposed and seconded by the president and secretary of the institution/association.
 - (vi) Such institution shall have paid their fees for the year **2025-26** as per their membership strength as on 31st March 2025 before submission of the nomination form.
5. In case of an election for the post of senior vice president nominations received either from the institutional category or individual category, a vote shall be cast by all the individual members and the president and secretary of the institutional members in the election to be held online.
 6. In case of election in the institutional category for the post of managing committee members, voting rights shall be vested with president and secretary of all institutional member associations for the election of **eight (8)** institutional members of other than the Ahmedabad zone.
 7. In the case of election of an individual category for the post of member of the managing committee, all individual members of the federation shall have equal rights to vote. Out of **eighteen (18)** members, **seven (7)** members from other than the Ahmedabad zone shall be elected.
 8. In the event of nominations received are exceeding the specified limits for post of member of the managing committee or senior vice president as above for Ahmedabad and out-station category, the election will be held as per the directions of the Election Committee.
 9. **Election Process:**
 - (i) A detailed online election process is provided herewith in a separate document.
 - (ii) Valid nomination forms will be displayed on the website or circulated by e-mail of the federation on **19th May 2025, after 6.00 PM** and will be informed to the candidates by electronic mode.

3. In case where election needs to be conducted, the Zoom registration links will be shared on the e-mail ID of the members. Members need to register on the same to be eligible to participate in the election by **27th May 2025 by 6.00 PM**.
4. In case of no election, the proceedings of the election meeting shall be taken at the Annual General Meeting to be held on **31st May 2025**.
5. If any clarification is required for the smooth functioning of an election, office bearers in consultation with scrutinizers, may issue clarification and instruction and communicate the same through members' registered mail ID and display the same on website of the association.
